

GEORGIA LOTTERY KICK TO SCORE CONTEST ("Contest") OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

OPEN ONLY TO ELIGIBLE RESIDENTS OF THE STATE OF GEORGIA, WHO, AS OF THE TIME OF ENTRY, ARE AT LEAST EIGHTEEN (18) YEARS OF AGE.

THIS CONTEST IS SUBJECT TO ALL APPLICABLE FEDERAL AND STATE LAWS AND REGULATIONS AND IS VOID WHERE PROHIBITED.

1. ELIGIBILITY: Open only to legal residents of the state of Georgia who are at least 18 years of age, and who have mobile internet access and a Qualified Device as of June 1, 2020. A "Qualified Device" means (a) an Apple mobile device (iPhone 7 and newer) with an iOS 10.0 operating system or newer and the Safari or Chrome web browser or (b) as of June 1, 2020, mid to high tier Android device with Android 7.0 or newer and the Chrome web browser. The following persons are not eligible to participate or win a prize: employees, directors and officers of Aquimo LLC ("Aquimo"), Georgia Lottery Corporation ("GLC" or "Sponsor"), Major League Soccer, L.L.C. and its member teams including Atlanta United ("MLS"), and Soccer United Marketing, LLC ("SUM" and MLS, the "MLS Entities"), and each of their respective parents, subsidiaries and affiliated companies, distributors, web design, advertising, fulfillment, and promotion agencies, and other parties involved in the administration, development, fulfillment or execution of this Contest (collectively the "Contest Parties"), the immediate family members (spouse, parent, child, sibling, grandparent, and spouse or "step") of each of the foregoing excluded persons, and those living in the same household of each such individual.

2. HOW TO COMPETE: Six (6) week-long Contests will be held from June 7, 2020, to July 18, 2020, the "Contest Period". Each week-long contest, the "Weekly Contest", will start at 9 AM Eastern time (09:00) on Sunday and end at midnight Eastern time (24:00) on Saturday, the Weekly Contest Period. The Contest Period will end at midnight Eastern Time (24:00) on July 18, 2020.

In addition to the Weekly Contests there may be up to four (4) live event games, the "Live Contests", with celebrity contestants: TBD

The Live Contests are announced on the Game home screen when the event is going live. Celebrity contestants are subject to change.

To participate, players must navigate to ATLUnited.live using the Chrome or Safari web browser on their Qualified Device. To enter the Weekly Contest, during the Contest Period, touch "Play Now" on the Game home screen to enter "Tournament Play" mode. The Tournament Play is automatically initiated, and the Game takes approximately 60 seconds to play. Participants may play unlimited times each day in Tournament Play mode. However, only the single highest Tournament Play score for any individual during any Contest Period shall be eligible for prizes for that Contest Period or be posted to the official Contest Leaderboard. To enter the Live Contests, navigate to the home screen of the Game a few minutes before the live event is scheduled to begin. The Live Contests, at the times set forth above, is announced on the home screen of the Game and is automatically initiated so that "Play Now" is head-to-head Tournament Play, which will be live for approximately 60 seconds, the "Challenge Play". Contestants may view the Live Contest and the celebrity player and interview using a separate web

browser on [twitch.tv/AquimoSports](https://www.twitch.tv/AquimoSports). Contestants may enter the Live Contest unlimited times while the contest is live broadcast on Twitch. Some of the contests will be announced as practice games – only the game announced on [twitch.tv/AquimoSports](https://www.twitch.tv/AquimoSports) as the Live Contest for prizes will award prizes as set forth below.

If you play in a Weekly Contest or a Live Contest during the Contest Period, you become a “Contestant”. After each Tournament Play or a Live Contest in the Contest Period, your total score is automatically posted to the official Contest leaderboards (“Leaderboards”). The length of each Weekly Play or Live Contest Game is at the discretion of the Sponsor and Aquimo. If you play before or after the Contest Period has ended, your score for such Tournament Play is a practice score and is just for fun. Such score shall not be added to the Leaderboards or be eligible for the Contest. Aquimo’s application system is the official time-keeping device for the Contest.

To participate, you must do the following:

- A. Navigate to [ATLunited.Live](https://atlunited.live) using the Chrome or Safari web browser.
- B. Log-in using social media or enter as a guest by entering a unique username.
- C. Tap “Play Now” in the Game. Note that the Weekly Tournament Play will start automatically if the Game is open and you tap “Play Now.”

To enter and participate in a Live Contest, open the Game and go to the home screen before the game is scheduled to begin. When the Live Contest is activated touching “Play Now” on the home screen of the Game will initiate a count down and all Contestants who are active will play simultaneously for approximately 60 seconds. From time to time as practice before the Live Contest, live tournaments may be initiated without prizes that are “Practice Games”. The Practice Games do not award prizes and the end of game screen says “Thanks for Playing the Practice Game”. Such score shall not be added to the Leaderboards or be eligible for the Contest.

D. At the end of the Tournament Play or Live Contest, your score will be automatically updated to the Leaderboards. The Weekly Leaderboard records the scores for the Weekly Tournament Play and the Live Event Leaderboard records the scores for the last Live Contest. Scores from Live Contest Games shall not be added to the Weekly Tournament Play Leaderboard. You can tap Play Now to compete in Tournament Play again and there is no limit to the number of times you can play each day in the Weekly Contest.

E. Share your valid email address.

To participate and win, you must have a Qualified Device (see above), have shared your valid email address, have a data plan through your online service provider, and Internet access, all as of the start of and during the Contest Period. Any data charges assessed by your own mobile service provider or charges for Internet access are your sole responsibility.

3. HOW TO WIN: The Contest occurs on the dates and times set forth in paragraph 2 and there are two (2) ways to win:

Prizes are awarded (1) to the individuals with the highest overall Tournament Play scores during each Weekly Contest Period, excluding all Live Contest scores (six (6) sets of winners, one (1) each week); and

(2) to the individuals with the highest overall scores of each Live Contest (up to four (4) total sets of winners) (collectively, the “Winners”). The eligible individual with the highest overall score for any Weekly Contest or Live Contest will be awarded the 1st Prize for that Contest. The eligible individuals with the 2nd through 5th highest overall scores for any Weekly Contest or Live Contest will be awarded the 2nd Prize for that Contest. The eligible individuals with the 6th through 100th highest overall scores for any Weekly Contest or Live Contest will be awarded the 3rd Prize for that Contest. The top 500 eligible individuals in any Weekly Contest or Live Contest, including all 1st, 2nd, and 3rd Prize Winners for that Contest, will be awarded the 4th Prize for that Contest. Scores from Live Contests shall not be eligible for the Weekly Contests.

In the case of a tie score the Winner will be determined based upon the time that the score was obtained in the Tournament Play or during the Live Contest, as applicable. The fastest time will be awarded the Winner.

PRIZE REDEMPTION: Potential Winners will be contacted by email with prize redemption instructions and will be asked to verify eligibility and sign a Winner Agreement and Release of Liability Form with (where lawful) a publicity release. If a potential Winner does not respond within the designated time, or there is a return of any prize/prize notification as undeliverable, he/she may be disqualified and the next highest Tournament Play scoring eligible Contestant for the applicable Weekly Contest Period or Live Contest, as applicable, will be selected. A Georgia Lottery Winner Claim form will be provided to potential winners and must be returned within seven (7) days of receipt. Failure to timely return any required documents, including the Georgia Lottery Winner Claim Form, may result in prize forfeiture, and an alternate winner may be selected. Unless otherwise noted, allow eight (8) to ten (10) weeks for delivery of prizes by email to the address indicated following completion of notification and the prize claim process.

8. GENERAL CONDITIONS:

This Contest is governed by the laws of Georgia. As a condition of participating in this Contest, Contestant agrees that any and all disputes that cannot be resolved between the parties, and causes of action arising out of or connected with this Contest, shall be resolved exclusively before the Superior Court of Fulton County, Georgia. Prizes will be awarded and/or delivered only to addresses within the

State of Georgia. Except as determined by Sponsor in its sole discretion, no substitution of prize is offered, no transfer of prize to a third party is permitted, and non-cash prizes may not be redeemed for cash value (unless at the sole discretion of Sponsor).

Winners will be solely responsible for all applicable federal, state and local taxes and related expenses on the prize and may receive an IRS Form 1099 for the approximate retail value of the prize (as calculated by Sponsor). Winners may be required to complete and return to Sponsor or Aquimo an IRS FORM W-9 as a condition of receiving a prize.
